

The John D. McCann Scholarship Fund/Application

The John D. McCann Scholarship Fund is a grant and scholarship program specifically intended for the use of seminary students under the care of the Presbytery of East Iowa. The fund was established in 1985 and is stewarded by the Presbytery to honor the memory and work of the Reverend John D. McCann, who served as the Director of Clinical Pastoral Education for the Alcohol Treatment Center located on the University of Iowa Campus. A minister member of the Presbytery for over two decades, Reverend McCann engaged in service on the Committee on Preparation for Ministry and was deeply involved in all aspects of the preparation process. His passion for effective, comprehensive ministry preparation is supported through this scholarship.

At all ordination and installation services, the offering shall be designated in support of the John D. McCann Scholarship Fund. It is also appropriate for churches to receive a special offering in support of this fund on Theological Education Sunday and/or any special occasion upon which the church seeks to raise awareness of the importance of ministry preparation and the financial needs of seminary students.

Any Inquirer or Candidate is eligible to apply for funding not to exceed \$500 during the period of seminary study to cover documented expenses related to the preparation process. In addition, any Inquirer or Candidate may apply to receive a need-based scholarship of \$500 on a one-time basis if a financial emergency arises. The Committee on Preparation for Ministry of the Presbytery of East Iowa is responsible for evaluating and awarding monies from the McCann Fund.
